Since September, Scott has been unable to work, he is currently on his second chemo drug and has started to use Optune (electromagnetic stimulation to the brain). We have adjusted well to our new normal, but not without the help of many, including Gray Warriors, who paid our mortgage for us in December. We can't even express what a lifesaver that was. To have that financial relief, especially around Christmas, helped ease our stress and meant that we could enjoy the holidays a little more.
